



Weekly Draw & TC

Eligibility

- This campaign is open to all customers who obtain a Gold Loan facility from CDB Finance PLC during the campaign period.
- Customers who obtain a Gold Loan advance of LKR 10,000 or above will be eligible to participate in the raffle draw.
- One entry will be allocated for every LKR 10,000 disbursed (e.g., LKR 100,000 = 10 entries).

Draw Mechanism

- Winners will be selected on a weekly basis through an automated raffle draw system.
- The raffle draw will be conducted at the Head Office of CDB Finance PLC.
- 1st week entry list will not be carried out to next week or future weeks raffle draw.

Prize Details

Bill Eligibility

- When the bill comes under property owner, consent letter from owner is must

Winner Limitations

- A customer is eligible to win only once during the campaign period.

- Winners will be notified via SMS, phone call, and/or official communication channels.

- Employees of CDB Finance PLC are not eligible to participate in this campaign.

- The number of winners will be determined based on the available budget.
